## Introduction

This report describes the outputs provided during the 2007/08 financial year under the non-departmental output classes of *Support for Victims*, *Intensive Intervention for Serious Recidivist Young Offenders* and *Crime Prevention and Community Safety Programmes*.

Key activities during the year under the *Support for Victims* output class included the provision by Victim Support of 24-hour personalised support services, counselling for families and friends of homicide victims, and the provision of assistance to help victims attend relevant parole board meetings, court trials and sentencing hearings. The Repeat Victimisation (Target Hardening) Programme provided assistance (such as burglar alarms) to victims of repeat burglary.

The key achievement under the *Intensive Intervention for Serious Recidivist Young Offenders* output class was the successful completion of the first year of the Te Hurihanga Youth Residential Programme. The Programme is a three year pilot for serious and recidivist young offenders. The outcomes of the pilot will help inform future approaches for addressing youth offending.

Under the *Crime Prevention and Community Safety Programmes* output class, work focused on the provision of funding for the delivery of crime prevention initiatives and programmes in partnership with local communities. Additional funding of \$6 million over three years was made available during the year to help local councils and community groups undertake community-based anti-tagging initiatives. Funding was also made available for the delivery of restorative justice services by community-based organisations. New restorative justice services in two locations were rolled out and a new national restorative justice facilitator training and assessment programme was launched. Funding was made available to increase the use of restorative justice in cases involving graffiti vandalism, and ongoing support was provided to Restorative Justice Aotearoa.

# Statement of Service Performance

## NON-DEPARTMENTAL OUTPUT CLASS

### Support for Victims

#### **Scope of Appropriation**

This output covers the purchase of services through the New Zealand Council of Victim Support Groups Incorporated (Victim Support) for the provision of services to victims of crime.

#### **Intended Impacts, Outcomes or Objectives**

The services and activities provided under this output class contribute to the justice sector outcomes of safer communities, civil and democratic rights and obligations enjoyed, and impact of crime reduced. The intended impact of these services and activities is that victims of crime and trauma are supported by information and financial assistance.

#### **Description of Activities**

This output class covers funding for the purchase of services to victims of crime and trauma provided by Victim Support. The services provided by Victim Support include 24-hour personalised support services, and administration of Victims Assistance Schemes that help victims to attend relevant meetings of the New Zealand Parole Board, court trials and sentencing hearings, and provide counselling for families of homicide victims. A pilot scheme called the Repeat Victimisation (Target Hardening) Programme provides extra assistance (such as the provision of burglar alarms) to victims of repeat burglary.

### *Comments*

Projections for seven performance measures were met or exceeded. Projections were exceeded for the average number of contacts per victim and the number of discretionary grants provided to families of homicide victims. Standards were met for the number of audits of Victim Support offices and the processing of requests for financial assistance. Standards were also met for the number of contacts with victims seeking assistance to make submissions at parole hearings, as well as the timely provision of performance reports and draft material for 2008/09 Memoranda of Understanding.

Projections for the remaining 12 performance measures were not met. In some cases, this is because the measures are demand driven which makes forecasting difficult. During the year, Victim Support focused on improving the quality of services provided to victims of serious crime. This resulted in fewer overall incidents responded to, but an increase in the number of contacts per victim. Future work by Victim Support will involve the development of performance measures that better reflect this focus.

### **Financial**

The appropriation for Support for Victims for the 2007/08 year was \$5.446 million. Actual expenditure for the year ending 30 June 2008 was \$5.446 million. The 2006/07 appropriation was \$5.118 million. Actual expenditure for the year ending 30 June 2007 was \$5.118 million.

# Statement of Service Performance

## NON-DEPARTMENTAL OUTPUT CLASS

### Intensive Intervention for Serious Recidivist Young Offenders

#### **Scope of Appropriation**

This output includes the provision of funding for the Te Hurihanga Programme, which aims to provide an intensive rehabilitation and reintegration programme for serious and/or recidivist young offenders. It will initially operate as a pilot programme in Hamilton. Lessons from the pilot will be used to develop ways to effectively address youth re-offending.

#### **Intended Impacts, Outcomes or Objectives**

The services and activities provided under this output class contribute to the justice sector outcomes of safer communities, crime reduced, and impact of crime reduced. The intended impact of these services and activities is that young offenders are held to account, their re-offending is reduced, and they are provided with a more constructive future.

#### **Description of Activities**

This non-departmental output class covers funding for the Te Hurihanga Programme, which has been established as a three year pilot programme for young offenders. Based in Hamilton, the programme is being operated by the Youth Horizons Trust. The pilot was launched on 1 April 2007.

### Comment on Variance

The appropriation for 2007/08 includes a carry forward from previous years. There was almost two years' delay to the start of the Te Hurihanga programme, due to lengthy search and resource consent processes prior to the building of the residence. The programme commenced on 1 April 2007. The appropriation has been carried forward to allow the three year pilot programme to continue.



# Statement of Service Performance

## NON-DEPARTMENTAL OUTPUT CLASS

### Crime Prevention and Community Safety Programmes

#### **Scope of Appropriation**

This output covers funding for the co-ordination and delivery of a range of crime prevention initiatives in partnership with local communities. Funding is made available to assist territorial authorities and iwi providers to implement crime prevention plans. The Ministry also contracts a variety of organisations to carry out crime prevention projects in specific areas, including youth at risk, community and sexual violence prevention, theft of and from cars, and community managed restorative justice.

#### **Intended Impacts, Outcomes or Objectives**

The services and activities provided under this output class contribute to the justice sector outcomes of safer communities, crime reduced, impact of crime reduced, and a trusted justice system. The intended impact of these services and activities is that local authorities and communities are engaged in programmes that focus on the reduction of crime through preventative measures and on increasing community safety.

#### **Description of Activities**

This non-departmental output class covers co-ordinating and delivering a range of crime prevention initiatives and programmes in partnership with local communities, and the delivery of restorative justice services. The programmes and services are contracted by the Crime Prevention Unit within the Ministry of Justice and are purchased from territorial authorities and other selected service providers.

#### **Crime Prevention Initiatives and Programmes**

Funding is provided to territorial authorities and iwi on criteria determined by their crime prevention needs, including the size of population and crime rates. Contract management services and grant funding is provided either on the basis of a crime prevention plan (strategic partnerships) designed to meet local needs or approved crime prevention projects (operational partnerships). The Ministry also provides contract management services and grants to non-government organisations to deliver specific crime reduction projects.

In 2007/08, crime reduction projects were designed to reduce the incidence and impact of crime, in the seven key goal areas of the Government's Crime Reduction Strategy: family violence and child abuse; other violence and sexual violence; serious traffic offending; youth offending and re-offending; burglary; theft of and from cars; and organised crime.

These crime reduction projects were particularly targeted to the following high need and at risk groups comprising:

- Māori
- Pacific peoples
- 'at risk' families
- those affected by drugs, alcohol or gambling.

The Crime Prevention Unit has developed an anti-tagging and graffiti vandalism strategy, known as STOP (Stop Tagging Our Place). The strategy will provide the foundation for a nationwide approach to the issue. As part of the strategy, the government is committing \$6 million over three years to support local councils and community groups to undertake community-based anti-tagging initiatives.

### **Restorative Justice**

Funding is provided to community-based organisations to deliver restorative justice services at the pre-sentence stage of the court process (following a guilty plea) and as part of the Police Adult Diversion Scheme (where compliance with an agreed plan will result in a withdrawal of the charges).

In addition to funding restorative justice service delivery, a number of initiatives to improve and extend services and ensure overall high quality were funded in 2007/08. These included:

- new restorative justice service provision in two locations
- a new national restorative justice facilitator training and assessment programme
- funding to increase the use of restorative justice in cases involving graffiti vandalism, as part of the STOP strategy
- support for the national association (Restorative Justice Aotearoa), including work contributing to a national framework to establish standards of practice, a new funding arrangement for restorative justice providers and a national practitioners' conference.

#### Comments

In 2007/08, relationships with territorial authorities and other organisations were split into strategic and operational partnerships. The combined number of strategic and operational partnerships in 2007/08 was 58 (19 strategic partnerships and 39 operational partnerships), compared to 55 calculated on an equivalent basis in 2006/07.

A number of grants were made using the additional funding that was made available in 2007/08 for anti-tagging initiatives (refer to appendix three). This did not have a significant impact on the number of operational partnerships with territorial authorities but resulted in significant over-performance regarding the number of projects delivered by community providers.

**Financial**

The appropriation for Crime Prevention and Community Safety Programmes for the 2007/08 year was \$7.950 million. Actual expenditure for the year ending 30 June 2008 was \$7.950 million. The 2006/07 appropriation was \$5.950 million and the 2006/07 actual expenditure was \$5.950 million.

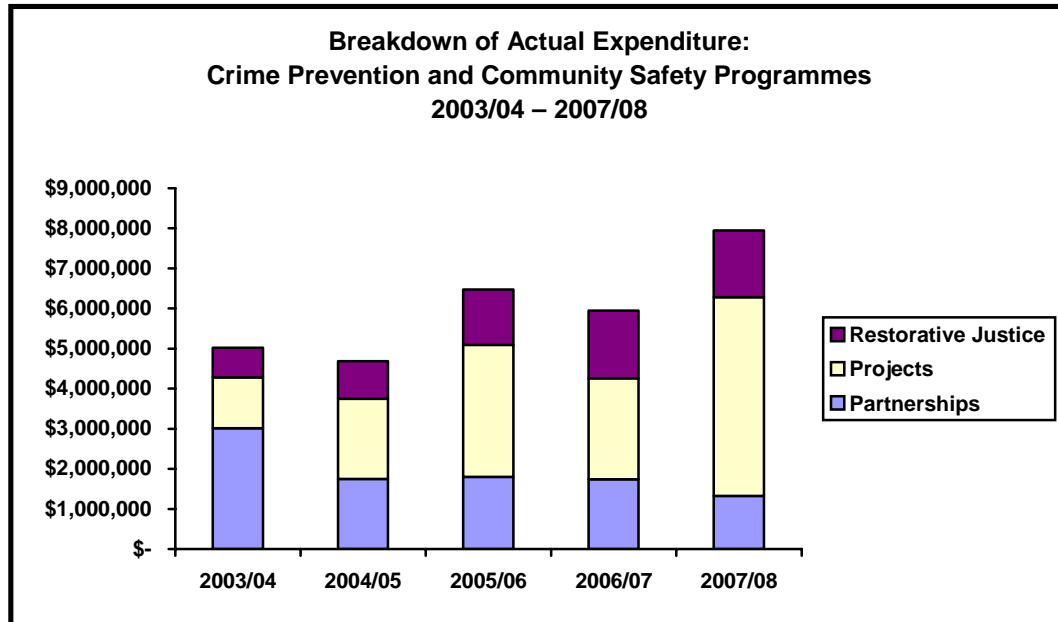
