

## Plumbers, Gasfitters, and Drainlayers Board (Fees, and Disciplinary and Prosecution Levy) Amendment Notice (No. 2) 2023

The Plumbers, Gasfitters, and Drainlayers Board (“Board”), under section 143 of the Plumbers, Gasfitters, and Drainlayers Act 2006 (“Act”), issues the following notice to amend the Plumbers, Gasfitters, and Drainlayers (Fees, and Disciplinary and Prosecution Levy) Notice 2021, published in the [New Zealand Gazette, 29 November 2021, Notice No. 2021-gs5150](#).

### Notice

#### 1. Title

This notice is the Plumbers, Gasfitters, and Drainlayers Board (Fees, and Disciplinary and Prosecution Levy) Amendment Notice (No. 2) 2023.

#### 2. Commencement

This notice comes into force on **15 March 2023**.

#### 3. Principal Notice

This notice amends the Plumbers, Gasfitters, and Drainlayers Board (Fees, and Disciplinary and Prosecution Levy) Notice 2021 (“principal notice”).

#### 4. Amendment Notice Revoked

This notice revokes the Plumbers, Gasfitters, and Drainlayers Board (Fees, and Disciplinary and Prosecution Levy) Amendment Notice 2023 published in the [New Zealand Gazette, 24 January 2023, Notice No. 2023-gs241](#).

#### 5. Purpose

The purpose of this notice is to replace the disciplinary and prosecution levy in paragraph 5(1) of the principal notice.

#### 6. Paragraph 5(1) Amended

*Disciplinary and prosecution levy replaced*

(1) The Disciplinary and prosecution levy in paragraph 5(1) is revoked and the following Disciplinary and prosecution levy is substituted:

This notice is issued under sections 142 and 143 of the Plumbers, Gasfitters, and Drainlayers Act 2006.

### Explanatory Note

*This note is not part of the notice and has been included to explain its general effect.*

Under section 143 of the Act, the Board may impose a disciplinary and prosecution levy on all registered persons.

In 2021, the Board set the Disciplinary and prosecution levy at \$300.00. Following a review of the levy, the Board has reduced the Disciplinary and prosecution levy to \$275.00.

The new disciplinary and prosecution levy will apply from 13 March 2023 onwards.

This notice revokes and replaces an earlier amendment notice issued by the Board which did not comply with section 145 of the Act.

This notice is administered by the Plumbers, Gasfitters, and Drainlayers Board.
